Oren Kelly Conley has filed an application for appeal from a judgment finding him in contempt regarding the child support provisions of the parties' final divorce decree. Because a certificate of immediate review was included in Conley's application, the submission was docketed as an application for interlocutory appeal as a matter of course. Pretermittting whether the application should be redocketed as an application for discretionary appeal, we find that the order complained of falls within the Supreme Court's divorce and alimony jurisdiction. Because this action is ancillary to the parties' divorce proceeding, a matter within the Supreme Court's appellate jurisdiction, this appeal is hereby *transferred* to the Supreme Court for disposition. Ga. Const. of 1983, Art. VI, § VI, Par. III (6); *Griffin v. Griffin*, 243 Ga. 149 (254 SE2d 80) (1979); see also *Brown v. King*, 266 Ga. 890 (472 SE2d 65) (1996); *Smith v. Smith*, 254 Ga. 450, 452 (2) (330 SE2d 706) (1985); *Hines v. Hines*, 237 Ga. 755 (1) (229 SE2d 744) (1976); compare *Ashburn v. Baker*, 256 Ga. 507 (350 SE2d 437) (1986) (jurisdiction in contempt action involving child custody issues, but not issues relating to divorce and alimony, is with the Court of Appeals).



Chatham County sheriff Al St. Lawrence has filed a petition for interlocutory appeal from the denial of his motion seeking an order to transfer defendant Frank Joseph Schwindler to the Georgia Department of Corrections. St. Lawrence argues that OCGA § 42-5-50 (c)¹ does not apply here because Schwindler is not represented by an attorney.

Because the order appealed from fully disposed of the applicant's post-conviction motion, the interlocutory appeal procedure is not required here. See generally *ITT Terryphone Corporation v. Modems Plus, Inc.*, 171 Ga. App. 710 (320

¹"In the event that the attorney for the convicted person shall file a written request with the court setting forth that the presence of the convicted person is required within the county of the conviction, or incarceration, in order to prepare and prosecute properly the appeal of the conviction, the convicted person shall not be transferred to the correctional institution as provided in subsection (b) of this Code section. 

Darren Edward Carswell filed this application for interlocutory appeal, seeking appellate review of the trial court's order denying his motion to dismiss, which was entered on January 10, 2002. OCGA § 5-6-34 (b) provides that where the trial court renders an interlocutory order and certifies it for immediate review within ten days of entry of the order, the appellate courts of this State may permit an appeal if the application is made within ten days after such certificate is granted. In this case, the trial court never entered a certificate of immediate review, but did grant an extension of time to file an application for interlocutory appeal on April 11, 2002.

However, not only did the trial court have no authority to grant an extension of time for filing an interlocutory appeal, but it also never complied with the statutory requirement of entering a certificate of immediate review within ten days after entry of the order sought to be appealed. *Smith v. State*, A91I0085 (unpublished, decided April 10, 1991). Cf. *Rosenstein v. Jenkins*, 166 Ga. App. 385 (304 SE2d 740) (1983)(no extensions of time for filing discretionary applications authorized). "While the trial court has the authority under OCGA § 5-6-39 to grant a 30-day extension of time for filing a notice of appeal, there is not comparable authority for granting an extension of time for filing an application" *Id.*, or for obtaining a certificate of immediate review.

To be effective, a certificate of immediate review must be signed and filed within 10 days of the entry of the order to which the certificate refers. *Turner v. Harper*, 231 Ga. 175 (200 SE2d 748) (1973). In this case, the certificate of immediate review was not filed until 13 days after entry of the order to which the certificate refers. Because the certificate of immediate review was untimely, this Court lack jurisdiction to consider this application. Accordingly, this application is ordered DISMISSED.
