Defendant DBL, Inc., seeks an interlocutory appeal of two orders certified by the superior court for immediate review. One of the orders appealed from granted in part plaintiffs' motion for interlocutory injunctive relief. An order granting an interlocutory injunction is directly appealable under OCGA § 5-6-34 (a) (4); *Saxton v. Coastal Dialysis & Medical Clinic*, 267 Ga. 177 (467 SE2d 587) (1996). Moreover, other orders entered in the case are likewise directly appealable pursuant to OCGA § 5-6-34 (d). Because applicant's submission meets all the procedural requirements for a timely filed application for discretionary appeal under OCGA § 5-6-35 (b), we deem it appropriate to treat the application as one for discretionary appeal. As such, the application is hereby *granted* under OCGA § 5-6-35 (j).<sup>1</sup>

Applicant shall have ten days from the date of this order to file their notice of appeal. The clerk of the superior court is directed to include a copy of this order in the record transmitted to this court.

Compare *Artis v. Gaither*, supra (dismissal of interlocutory appeal involving order directly appealable under OCGA § 9-11-56 (h) but not OCGA § 5-6-34 (a)). By its express terms, OCGA § 5-6-35 (j) applies only in those cases where the order complained of is "enumerated in subsection (a) of Code Section 5-6-34."

R. P. C., Inc., et al. seek interlocutory review of the order of the trial court denying their motion to dismiss this suit on the grounds of forum non conveniens. The common-law doctrine of forum non conveniens is an equitable principle by which a court in this state may decline to exercise its existing jurisdiction over a case on consideration of convenience, efficiency, and justice. *AT & T Corp. v. Sigala*, 274 Ga. 137 (549 SE2d 373) (2001). In considering the factor of justice, a trial court has great latitude in determining what matters to consider in determining the propriety of granting equitable relief and declining to exercise its jurisdiction over a particular case. And, "trial courts should have the discretion to determine whether a tort action should remain on their dockets when it involves foreign plaintiffs." *Id.* at 139; see also *Southern R. Co. v. Parker*, 194 Ga. 94 (1) (21 SE2d 94) (1942).

Examining the facts presented in this application in light of the current state of the law in Georgia, it appears that the underlying legal issue in this application is the propriety of granting equitable relief to the applicants under the doctrine of forum non conveniens. The issue of "propriety" of granting or denying relief under the doctrine of forum non conveniens is further evident because a trial court has inherent and constitutional authority to "exercise such powers as necessary in aid of its jurisdiction, and thus only the question of propriety remains to be resolved. Ga. Const. of 1983, Art. VI, Sec. I, Par. IV.

"Whether an action is an equity case for the purpose of determining jurisdiction on appeal depends upon the *issue* raised on appeal, not upon how the case is styled nor upon the kinds of relief that may be sought by the complaint. That is, 'equity cases'

are those in which a substantive issue on appeal involves the legality or propriety of equitable relief *sought* in the superior court – whether the relief was granted or denied.” (Second emphasis supplied.) *Beauchamp v. Knight*, 261 Ga. 608, 609 (2) (409 SE2d 208) (1991); accord *Saxton v. Coastal Dialysis &c.*, 267 Ga. 177, 178-179 (476 SE2d 587) (1996). As this application presents a substantive issue regarding the legality or propriety of the equitable relief sought in superior court, that is, application of the doctrine of forum non conveniens, the Supreme Court of Georgia has exclusive appellate jurisdiction over this application. Ga. Const. of 1983, Art. VI, Sec. VI, Par. III (2).

Accordingly, this case is ordered TRANSFERRED to the Supreme Court of Georgia. Ga. Const. of 1983, Art. VI, Sec. I, Par. VIII.

## **A03I0021. AFLAC INCORPORATED v. CHUBB & SON, INC. ET AL.**

AFLAC Incorporated filed an action against Chubb & Son, Inc. and other insurers, seeking, inter alia, a declaratory judgment as to the insurers' obligations to provide coverage for "Y2K"-related losses. AFLAC then filed a "Motion for Partial Summary Judgment and Declaratory Relief," seeking summary judgment and a declaratory judgment from the court on the issue of the insurers' obligations to provide this coverage. In its order denying the motion, the trial court stated, "viewing the evidence in a light most favorable to the non-moving party, [AFLAC] has failed to make out a prima facie case necessary to entitle it to judgment as a matter of law. THEREFORE, IT IS ORDERED, that [AFLAC's] Motion for Partial Summary Judgment and Declaratory Relief is HEREBY DENIED." AFLAC filed this application for interlocutory appeal from this order.

Normally, the interlocutory appeal procedures of OCGA § 5-6-34 (b) must be followed to take an appeal from the denial of a motion for summary judgment. In this case, however, the only issue for the court to decide was whether the insurance contracts provided the contested coverage. The construction of an insurance contract is a question of law for the court. See *Travelers Ins. Co. v. Blakey*, 255 Ga. 699, 700 (342 SE2d 308) (1986). In denying AFLAC's request for declaratory judgment, the court effectually decided the only legal issue before it in favor of defendants. The

order at issue is thus a final order entering a declaratory judgment against AFLAC and in favor of the defendants. Such an order is directly appealable, because “[d]eclaratory judgments ‘have the force and effect of [final judgments] and [are] reviewable as such.’ OCGA § 9-4-2 (a).” *Sunstates Refrigerated Svcs. v. Griffin*, 215 Ga. App. 61, 62 (1) (449 SE2d 858) (1994); OCGA § 5-6-34 (a) (1); *Spivey v. Safeway Ins. Co.*, 210 Ga. App. 775 (1) (437 SE2d 641) (1993). This is the case even if other issues remain pending below. See *Sunstates Refrigerated*, supra. Accordingly, the proper procedure for appealing this order was by filing a notice of appeal with the trial court,<sup>1</sup> not by filing an application for interlocutory appeal. This Court thus lacks jurisdiction to consider this application, which is hereby DISMISSED. See *Artis v. Gaither*, 199 Ga. App. 114 (404 SE2d 322) (1991).

Donald W. Pate seeks an interlocutory appeal of the order denying his motion to dismiss on grounds of lack of personal jurisdiction and improper venue. Donald Pate and Jane Dykes Pate were divorced and the "Divorce, Judgment and Decree" incorporated a settlement agreement of the parties. Subsequently, Jane Dykes Pate filed an action for modification of child support and motion for contempt. The underlying subject matter of the pending suit involves the terms of the settlement agreement incorporated into the judgment and decree of divorce.

Although Donald Pate has filed his application with this Court, we conclude that appellate jurisdiction lies in the Supreme Court which has exclusive jurisdiction over appeals in all divorce cases. Ga. Const. of 1983, Art. VI, Sec. VI, par. III (6). Because the order sought to be appealed is an order attempting to dismiss a suit for modification of child support and motion for contempt directly resulting from the alleged violations of the terms of a settlement agreement incorporated in a judgment and decree of divorce, this Court lacks jurisdiction to consider this application. See *Keeler v. Keeler*, 263 Ga. 151 (439 SE2d 5) (1883); *Shapiro v. Lipman*, 259 Ga. 85 (377 SE2d 673) (1989); *Odem v. Odem*, 241 Ga. 451 (246 SE2d 308) (1978); compare *Lewis v. Lewis*, 270 Ga. 409 (509 SE2d 936) (1999).

Also, the portion of the pending suit seeking a motion for contempt to enforce a settlement agreement incorporated into a judgment and decree of divorce is ancillary to, and an incident of the divorce action, and jurisdiction to hear an appeal of this nature is vested with the Supreme Court of Georgia. See *Griffin v. Griffin*, 243 Ga. 149 (254 SE2d 80) (1979); see also *Brown v. King*, 266 Ga. 890 (472 SE2d 65)

Reyes answered and counterclaimed alleging that her constitutional rights had been violated and that she had become the subject of unlawful discrimination.

On May 29, 2002, the superior court entered a temporary injunction against Reyes and the City of Vidalia.<sup>1</sup> The order also reserved ruling on the constitutional issues raised by Reyes until a hearing set for October 21, 2002. The case thus remains pending below.

---

<sup>1</sup>Reyes was entitled to file a direct appeal from this order, but failed to do so. See OCGA § 5-6-34 (a) (4). A notice of appeal must be filed within 30 days after entry of the order appealed from. OCGA § 5-6-38 (a). The time for filing a notice of appeal from this order has expired.

Reyes filed a motion for reconsideration from this order and a motion for more definite statement. On August 29, 2002, the court denied these motions and dismissed Reyes' counterclaim. Reyes requested a certificate of immediate review, which the trial court signed on September 11, 2002. The certificate of immediate review, however, was never filed in the superior court clerk's office. On September 23, 2002, Reyes filed an application for interlocutory appeal in the Georgia Supreme Court, which transferred the case to this Court for decision on October 15, 2002.

For this Court to have jurisdiction to consider an application for interlocutory appeal, a certificate of immediate review must be filed with the trial court within ten days after entry of the order sought to be appealed. OCGA § 5-6-34 (b); *Turner v. Harper*, 231 Ga. 175, 176 (200 SE2d 748) (1973). Reyes' failure to have a certificate of immediate review filed with the trial court within ten days of entry of the order appealed from deprives this Court of jurisdiction to consider this application. Accordingly, this application is hereby ordered DISMISSED.

On August 16, 2002, the trial court entered an order denying Juan Lopez-Morales' motion to recuse Judge David L. Dickinson. A certificate of immediate review was filed on August 26, 2002. Lopez-Morales filed his application for interlocutory appeal with the Supreme Court on September 23, 2002. The Supreme Court found that jurisdiction over the questions raised in Lopez-Morales' application rests with this court. The application was transferred to this court on October 11, 2002.

OCGA § 5-6-34 (b) provides in part that [w]here the trial judge in rendering an order, decision, or judgment, not otherwise subject to direct appeal, certifies within ten days of entry thereof that the order, decision, or judgment is of such importance to the case that immediate review should be had, the Supreme Court or the Court of Appeals may thereupon, in their respective discretions, permit an appeal to be taken from the order, decision, or judgment *if application is made thereto within ten days after such certificate is granted.*

(Emphasis supplied.) Lopez-Morales did not file his application with the Supreme Court until 28 days after the trial court granted his certificate of immediate review. Although dicta in the Supreme Court's order suggests that the application was timely filed, it is abundantly clear that Lopez-Morales did not meet the ten day time requirement for filing his application as mandated under OCGA § 5-6-34 (b). Accordingly, the application is hereby dismissed for lack of jurisdiction. *Baynes v. State*, 189 Ga. App. 797 (377 SE2d 708) (1989).

Thuong N. Nhan, Xuyen Thi Nguyen, and Warren M. Schmitz Associates Realty, Inc. seek interlocutory review of an order granting partial summary judgment to Wellington Square, LLC and denying the applicants' cross-motion for summary judgment and motion to dismiss. Under OCGA § 9-11-56 (h), "[t]he grant of partial summary judgment as to one or more but fewer than all the claims or parties is reviewable by direct appeal if the notice of appeal is filed within 30 days of the rendition of such judgment." *Olympic Dev. Group v. American Druggists' Ins. Co.*, 175 Ga. App. 425 (1) (333 SE2d 622) (1985). Thus, an appeal of the order in this case should have been initiated by the filing of a notice of appeal. Nonetheless, because the application is timely and to avoid prejudice to the applicants arising from their choice of an incorrect route of appeal, the application is hereby ordered GRANTED. The applicants shall have ten days from the date of this order to file a notice of appeal with the trial court.
