*The Court of Appeals hereby passes the following order:*

**A03A0088.        THE STATE v. TOMMY BAILEY THOMPSON**  
**A03A0094.        THE STATE v. VICCI LEE**

On August 30, 2002, A03A0088. The State v. Tommy Bailey Thompson was docketed with this Court as an appeal from the State Court of Fulton County. On September 3, 2002, A03A0094. The State v. Vicci Lee was docketed in this Court, also an appeal from the State Court of Fulton County.

On September 19, 2002, the State filed Appellant's Brief in each docketed appeal. Thereafter, on October 1, 2002, the State filed a motion in each appeal to consolidate these appeals, stating the issue raised in both appeals is identical.

Administratively, these appeals do not trigger the mechanisms in the Court of Appeals of Georgia to require the clerk's office to docket the cases as companion or related appeals.

It is not uncommon for the Court of Appeals of Georgia to have appeals with identical issues. This occurs frequently in cases appealed from different courts and the same court. The only common factor in the above appeals is that they are both appealed from the Fulton State Court, although different trial judges, and that the State is arguing the identical issue in each appeal.

Upon consideration of the Motion to Consolidate filed in the above appeals, the same is hereby GRANTED. The clerk of this Court is directed to transfer A03A0094. The State v. Vicci Lee from the Fourth Division of the Court of Appeals of Georgia to the First Division of the Court of Appeals of Georgia. Both cases are docketed as January 2003 term cases and both shall be disposed of by the Court on or before the conclusion of the April 2003 term.
