A polygraph examination, also referred to as a psychophysiological detection of deception examination, was conducted. The details of the examination, the relevant questions asked during the examination and the examiner's opinion concerning the physiological responses recorded during the examination are attached.		

POLYGRAPH REPORT

On September 3, 2015, a polygraph examination was administered to Dr. Mazen Ali Abdalla in order to determine his truthfulness regarding the circumstances of his removal from employment with a medical group practice in Conyers, Georgia. The following information was available for preparation prior to the examination:

In 1996, Dr. Abdalla was employed at the Atlanta Nephrology Referral Center (ANRC), which was then located in Decatur, Georgia. He later became a partner and signed the partnership 1998 contract with two partners at that time. In 1998, Dr. Abdalla was employed at the ANRC in Conyers, Georgia, which specializes in the treatment of kidney disease.

Dr. Abdalla stated that between November 2005 and February 2006, the other four doctors at the ANRC met together several times and discussed a change in the original 1998 ANRC contract. Dr. Abdalla further stated he was told that the other four doctors gave the original contract to Attorney Sidney Welch, and they met with her behind his back. He also stated they discussed that any changes to the March 2006 ANRC contract will be Georgia Code changes only. In addition, Dr. Abdalla stated the other doctors gave him a copy similar to the original contract and they discussed it for about ten minutes as there were no changes and all five doctors signed and left the meeting.

Dr. Abdalla stated that in May 2006 the other four doctors put a new contract on his desk that had many changes including involuntary removal of a member, which was not in the first draft. Dr. Abdalla further stated he called both managers (Dr. Karen Muro and Dr. Zeev Sharon) and talked to them, but they denied any knowledge of a new contract. He also stated that the group met on May 9, 2006, during which they told him they were removing him in accordance with the new contract.

On September 3, 2015, Dr. Mazen Abdalla voluntarily appeared at the Law Firm of Andersen, Tate & Carr in Duluth, Georgia, for a scheduled polygraph examination. At the outset, Dr. Abdalla was furnished with a polygraph consent form, which he read, stated he understood, and subsequently signed. Dr. Mazen Abdalla was afforded a polygraph test during which the following relevant questions were asked:

- A. During that meeting with the other ANRC doctors, did you discuss that any changes to the March 2006 ANRC contract will be Georgia Code changes only? (Answer-Yes)
- B. Have you ever met Attorney Sidney Welch? (Answer-No)
- C. Have you ever discussed the written material changes in the March 2006 ANRC contract, including dissociation changes, with any of the other ANRC doctors? (Answer-No)

It is the opinion of the examiner that the recorded responses to the above relevant questions are not indicative of deception.

The polygraph examination administered to Mazen Ali Abdalla was an investigative examination. An investigative examination is a polygraph examination intended to supplement and/or assist an investigation for which the examiner has not been informed and does not reasonably believe that the results of the examination will be tendered for admission as evidence in a court proceeding.

Abdalla's polygraph examination was conducted in a room at the Law Firm of Andersen, Tate & Carr, P.C., in Duluth, Georgia. The room was free of distractions during the examination.

A motion sensor, also known as an activity sensor, was operational and in use throughout the in-test phase of Abdalla's polygraph examination.

The polygraph examiner's Lafayette LX-4000 polygraph instrument is regularly given a functionality test consistent with manufacture recommendations and in compliance with state and federal law. The examiner follows the recommendations of the manufacturer, Lafayette Instrument Company, and performs a functionality test on the LX-4000 at a minimum of once every year. Documentation is available upon request.

The polygraph examiner who conducted Abdalla's polygraph examination has completed forty-two continuing education hours during the past two years. This is consistent with and above the American Polygraph Association (APA) requirement that the examiner completes a minimum of thirty continuing education hours every two years in coursework related to the field of polygraph. Documentation is available upon request.

The polygraph examiner ensured that APA standards regarding pretesting and testing requirements were complied with during Abdalla's polygraph examination.


