Hello Ms. Bender,

As per the Court of Appeals order (A15D0543), I filed a Notice of Appeal with the lower court in Chatham County in Savannah, Georgia (DR14-0356J4) on the 4<sup>th</sup> of September 2015. On the 14<sup>th</sup> of September 2015 I received a letter from Ms. Patty Waller Appeal Clerk in Savannah (see enclosed) so I went in to speak with her.

Ms. Waller explained that I had to purchase the transcripts in order for her to send them to the Court of Appeals in Georgia. I once more provided the letter from the upper court and she then agreed to send them to you. However, she did say that the two case records that Judge Abbott ruled upon, that were transferred to her by Judge Bass (CS02-0003BA) and Judge Barker (N141198), would not be sent to you. As mentioned previously, my original civil case involving child custody and support was transferred from Judge Bass in 2012 to Judge Abbott with no reason given. So too was the magistrate case against Rau heard in Judge Barkers courtroom (and taped as are all criminal cases). Instead of arresting Rau for criminal trespassing, after Rau confessed and said that there was "sensitive information about Judge Abbotts court" on the lap top he took from my vehicle, Judge Barker stated "you just implicated yourself" Judge Barker promptly transferred the case to Judge Abbott and the taped hearing is "not on the tape" as per the court reporter official Suzie Rolfs Chapman (see enclosed).

I am not certain how these records are to be sent to you as Ms. Waller said she could not. Please let me know how the Court of Appeals would like me to proceed.


