SCHEDULING PERMITS THE STAFF AT WHEELER CORRECTIONAL FACILITY TO ALLOT A TIME
FRAME SINCE THEY ONLY ALLOW UP TO 8 INMATES PER BLOCK OF TIME AND THIS PRISON
HOLDS OVER 2600 INMATES.

THE ISSUES INVOLVED IN THIS CASE ARE COMPLEX AND TO COMPLICATE MATTER
WORSE WE ARE CURRENTLY ON A FACILITY WIDE LOCK-DOWN DUE TO A

SHAKE DOWN THAT IS BEING CONDUCTED FROM MARCH 23RD UNTIL THE 27TH
THIS WILL AFFECT MY RESEARCH TIME NEGATIVELY.
