Today I received Remittitur from Counsel (Steven Miller): I Do Not know where you folks obtained your information But I was not in the Floyd County Jail being investigated by Floyd P.D. on case 13-CR-377-JFH-001 (A14A1902)

I was in jail on an Absolute unrelated issue - case # 12 CR 02348B-JFH-001 and 13-CR-0216-JFH-001 = Nothing to do w/ 13-CR-377 JFH-001 case in which your findings in put and are Erroneous!

Also, you state I "fail" to raise grounds - I've not failed to do anything! I never wanted an attorney for Trial or appeal! Counsel was forced upon me! If I'd have had 1% of an attorney who would have represented me I would not have been convicted: 1st off, case 377 on pg 16 & 243 of the Transcript shows Jury Tampering via the Court which a Juror was Erroneously Empanelled & neither attorney addressed this issue! The record reflects Tampering w/ Evidence, Counsel refused to Subpoena & a lot more!
