Dear Clerk of Court:

On January 21, I received a Notice of Dismissal regarding my appeal A15A0901. I informed a clerk by phone on that day, that I had received the notice that my appeal had been dismissed. She stated that a remittitur of \$300.00 was due the court for filing the appeal. I mention to her that along with the certified court record sent to the Court of Appeals by the trial court (The Superior Court of Chatham County) that the trial court judge had granted my motion for a pauper's affidavit and sent it along with the court record. Also, I stated that I would be sending the proper notice to the court to file an appeal of the trial court's decision.

On February 6, 2015 I mailed by certified and returned receipt a copy of my Application for Discretionary Appeal. By now, this application should have arrived by mail at the office of the Clerk of Courts. I write to ask that the remittitur for my appeal not be sent back to the Superior Court of Chatham County.
