- An Application for Writ of Mandamus should be filed in the superior court of the county official whose conduct you intend to mandate. An appeal from a denial of an Application for Writ of Mandamus is to the Supreme Court and not the Court of Appeals.
- Your appeal was disposed by opinion (order) on _____. The Court of Appeals _____ . The remittitur issued on _____ divesting this Court of jurisdiction. The case decision is therefore final.



ORDER ON MOTION FOR NEW HEARING

Plaintiff has filed Motions for New Hearing on August 18, 2014 and October 10, 2014. This Court entered a Final Judgement and Decree on June 30, 2014. It entered an order on July 8, 2014 denying Plaintiff's request for a rehearing. A request for new trial where the Plaintiff would be entitled to a hearing, must be filed within thirty (30) days of the Court's judgment. O.C.G.A. §5-5-40. If the Court were to interpret these pleadings as Motions for New Trial, then said requests for hearings would not be timely since they were not filed within thirty (30) days of the Court's judgment (June 30, 2014). If the Court were to consider these pleadings as Motions for Reconsideration, although the August 18, 2014 Motion for New Hearing would be timely since it was filed within the same term of Court as the judgment, Plaintiff would not be entitled to a hearing on a Motion for Reconsideration.

WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Plaintiff is not entitled to a New Hearing and his motions are DENIED.


