You do not need to provide this Court with a copy of the Notice of Appeal you filed with the superior court.
- The Notice of Appeal must include a proper Certificate of Service.** A Certificate of Service must show service to the opposing counsel and contain the counsel's full name and complete mailing address. The opposing counsel must actually be served with a copy of your filing.
- An Application for Writ of Habeas Corpus should be filed in the superior court of the county in which you claim you are illegally detained.** An appeal from a denial of an Application for Writ of Habeas Corpus is to the Supreme Court and not the Court of Appeals.
- An Application for Writ of Mandamus should be filed in the superior court of the county official whose conduct you intend to mandate. An appeal from a denial of an Application for Writ of Mandamus is to the Supreme Court and not the Court of Appeals.**
- Your appeal was disposed by opinion (order) on _____.** The Court of Appeals _____
divesting this Court of jurisdiction. The remittitur issued on _____
- Your mailing/documents indicate that you intended to file your papers in another court rather than the Court of Appeals of Georgia.** The address of the Clerk of the _____ is: _____

- A request for an out-of-time appeal should be made to the trial court from which you are appealing.** If your motion is denied by the trial court, you can file an appeal of that decision by filing a Notice of Appeal with the clerk of the superior court.



Petition for Writ of Mandamus

Comes now the petitioner, Ion Harris #831283, and brings this his Petition for Writ of Mandamus against Judge ~~J.~~ J. Carlisle Overstreet of the Richmond County Superior Court, of the State of Georgia, and shows as follows:

The respondent judge, Judge J. Carlisle Overstreet, is the judge presiding over the case of Ion Harris v. Mental Health Parole Board and Georgia Department of Corrections, civil action number 2013-RCR-00362, which was filed in July 2013 by the petitioner. The defendant in that case failed to comply with O.C.G.A. § 9-11-12(a) and did not file an answer to the complaint of the petitioner, the petitioner filed a motion for default judgment in November 2014 but the judge, Judge J. Carlisle Overstreet fails to rule on the motion, which raises these facts. The petitioner has exhausted all available remedies available to him, the petitioner seeks the issuance of mandamus to receive default judgment and has no other remedy available to him in court.
