- An Application for Writ of Mandamus should be filed in the superior court of the county official whose conduct you intend to mandate. An appeal from a denial of an Application for Writ of Mandamus is to the Supreme Court and not the Court of Appeals.**

Comes now the petitioner, Ion Harris #831283, and brings this his Petition for Writ of Mandamus against Judge James G. Blanchard of the Richmond County Superior Court, state of Georgia, and shows as follows:

The respondent Judge, Judge James G. Blanchard, is the judge presiding over the case of Ion Harris vs. Georgia Department of Corrections, civil action number 2013-RCV-00595, which was filed October 31, 2013 by the petitioner. The defendant in that case failed to comply with O.C.G. §9-11-12(a) and did not file an answer to the complaint of the petitioner. The petitioner filed a motion for Default Judgment in November 2014 (see plaintiff's copy of stamped filed motion for Default Judgment attached to petition) but the judge, Judge James G. Blanchard fails to rule upon the motion, which raises these facts. The petitioner has exhausted all available remedies available to him, the petitioner seeks the issuance of mandamus to receive default judgment and has no other remedies available to him in court.
