ENUMERATION OF ERRORS

Appellant Benjamin Holmes brings forth the following causes of action and alleges the following:

1. Superior Court Judge issued an order dismissing my claim on June 17, 2015 for failure to served TCSG, a government entity, in a timely manner. See attached Exhibit A.
2. The Court stated that the dismissal was based on the alleged fact that TCSG had not been served for over seventeen months since Plaintiff filed the complaint.
3. TCSG-Okefenokee Technical College and Dr. Glenn Deibert, agent representing TCSG, was served on November 8, 2013. See Exhibit B.
4. Further, Plaintiff was informed by Sharon P. Horne, Assistant Attorney General for the Georgia Department of Law that "Please be aware that Office represents these parties an should be served with all pleading and correspondence directed to the undersigned." See Exhibit C.
5. The Court erred in the determination that the TCSG was not notified in a timely manner.

RELIEF

Plaintiff is requesting that the Court's Order be reversed and that Plaintiff be allowed to pursue his claims of Negligence against TCSG-Okefenokee Technical College.

his injuries nor that DOAS is in any manner vicariously liable for the negligence of TCSG. Therefore, Plaintiff fails to state a claim upon which relief can be granted against DOAS.


The Georgia Court of Appeals has stated that:

If the filing of the petition is followed by timely service perfected as required by law, although the statute of limitation runs between the date of the filing of the petition and the date of service, the service will relate back to the time of filing so as to avoid the limitation. Where service is belatedly perfected, the trial court may dismiss the action when the delay was caused by laches on the plaintiff's part. Service must proceed with diligence if the statute of limitation is to be tolled by the filing of the action.

Webb v. Murphy, 142 Ga. App. 649, 650 (1977) (internal citations omitted). Here, Plaintiff filed his complaint within two years of the injury allegedly caused by TCSG's negligence. Over seventeen months have passed since the complaint's filing, and Plaintiff still has not served TCSG. Given the lengthy extent of time that has passed since the complaint's filing and the ease with which Plaintiff could have served TCSG, a government entity, Plaintiff has failed to proceed with the diligence necessary for the filing of the action to toll the statute of limitations.

Accordingly, the Court hereby **GRANTS** the Motion to Dismiss.





COMPLAINT OF NEGLIGENCE

Plaintiff Benjamin Holmes brings forth the following causes of action and alleges the following:

1. Plaintiff is an individual and resident of Waycross, Georgia, USA.
2. Defendant is a corporation and at the time of this complaint, a resident of Waycross Georgia, USA.
3. On or about November 10, 2011, Plaintiff was asked by Mr. Thomas Wesley to wait outside his office at Okefenokee Technical College (OTC).
4. On or about November 10, 2011, Plaintiff found a seat in a nearby chair in or adjacent to the electronics laboratory.
5. On or about November 10, 2011, when Plaintiff sat down, the chair scooted back and tipped over causing Plaintiff to fall out of the chair and strike his head on the floor and a wall. Additionally, the back rest mechanism collapsed causing Plaintiff to be ejected from the chair.
6. On or about November 10, 2011, Plaintiff was taken to Satilla Regional Medical Center.
7. Based on examination by Dr. William Brown, Plaintiff was diagnosed with bad pain, cervical strain (whiplash) and low back pain/contusion.
8. At the time of the chair collapse, Plaintiff was 58 years of age.

Plaintiff brings forth the following counts and allegations supporting his cause of action:

COUNT 1 – NEGLIGENCE

Defendant failed to perform the duties in the written contract in a safe and effective manner leading to the injuries sustained by the Plaintiff.

1. Plaintiff believes that the chair was defective and therefore, there was a failure to warn of a potentially dangerous situation and /or instrumentality.

DAMAGES

1. As a result of the collapse, Plaintiff has been unable to perform his daily duties.
2. As a result of incident, Plaintiff sustained pecuniary and economic damages in the amount of \$2,000,000.

WHEREFORE, Plaintiff seeks compensatory damages in the amount of \$2,000,000 together with court costs.


