"Hello" my name is Demetrius Jernigan GDC#1280833 and i'm seiving a current sentence imposed by the Superior Court of Clayton County Georgia. My reason for contacting your Court's ARE the following reason's:

1) My trial counsel who was Mr. Willie Davis at the time was ineffective on the behalf of representing me before and at my trial hearing on the date of August the 28, 2012 in the Superior Court of Clayton County Georgia. the Case # at the time was #2012-CP-00827-09. I advised Mr. Willie Davis of the invalidity arrest warrants and my indictment. Mr. Willie Davis said that he was doing as he was paid to do. By the state. On August 28, 2012 i defendant Demetrius Jernigan was convicted of (1) courts (1) felonies and (2) misdemeanors.

(1.) 2) On my Motion for New Trial another Attorney for the Clayton County Appellate Circuit by the name of Mrs. Cindy Wang filed an amended motion to the Motion for New Trial hearing on the date of May 5, 2015. Motion for New Trial was Denied October 6, 2014. Mrs. Wang filed a Notice of Appeal on the date of October 22, 2014. Mrs. Wang was moved to another Division upon awaiting a decision of the Appeals Court on the behalf of case Appeals #AISA0765. Mrs. Cindy Wang accepted another position on February 19, 2015 and stayed on my case until she filed a Notice of Withdrawal from counsel on July 30, 2015. Mrs. Wang and another Counsel by the name of Kong Yo were active on my case before and after the decision of the Appeals Court on me being sentenced on a charge i shouldn't have been. Mrs. Wang was ineffective by not looking into the validity of my indictment and arrest warrants as i

had advised her to. Which has me false imprisoned under a void and fraudulent conviction violating my 5th 6th an 8th as well 14th amend Right to adequate Due Process.

3) Attorney Long No is ineffective by Not showing client to Attorney procedur's when he has been working on my case since the beginning of January of 2015. I have never spoken to he/she.

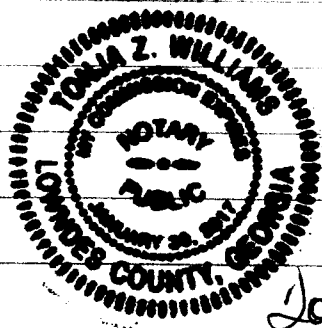
4) There is no court proceeding of my indictment hearing nor any transcript where I or my attorney was present in open court for the proceeding.
