



1.) I was arrested and taken into custody on 09/28/2011, in Columbus, GA, and charged with false report of a crime-1, in violation of O.C.G.A 16-10-26.

Shortly after graduating from medical school, my brother, Eddie Florence Jr., needed help in regards to transportation. I offered Eddie Florence Jr., as a present (free of charge) a Fairly Brand New Plymouth Neon (less than 3 years old) with the caveat, he place the title of the vehicle in his name and arrange travel time to come pick the vehicle up. A contract exist to the validity of this fact, and I transferred the title, which he signed. **EXHIBIT A, B, C, PAGE(S) 19, 20, 21**

After Giving Birth, I inquired about the vehicle to Eddie Florence Jr., as to the whereabouts of the vehicle, as my Brand New Vehicle, A Fully Loaded and Insured Warranty Covered 2009 Brand New White Range Rover HSE, was for the transportation for My Father and My Beautiful Daughter, because I was traveling quite often and wanted to utilize the Plymouth Neon for travel.

STATEMENT OF FACT IN SUPPORT OF APPEAL FOR MOTION OF DISMISSAL WITH PREJUDICE

At this point, I had no knowledge of Leslie Dinkins (located at 1537 Celia Drive, Columbus, GA 31906, Phone: 706-325-1999) and Leslie Dinkin's legal Fred levins Sr., Titles of Georgia (located at 1241 Broadway Columbus, GA 31901 (A PAWN SHOP), Phone: 706-393-1585). Eddie Florence, informed me a Mr. Leslie Dinkins was repairing the vehicle (an arrangement the two of them worked out unbeknownst to me). I later discovered Mr. Leslie Dinkins removed the vehicle from the original location of 2525 Skylake Drive Columbus, Georgia 31907. Once I was made aware of Mr. Leslie Dinkins' location, I reached out to inquire about the vehicle, Plymouth Neon. He complained about the vehicle being left at his residence, and he asked if I would ask Eddie Florence Jr., for the title. I asked Eddie Florence Jr., and his wife Angela Renae Field Vaughn Florence-Columbus police officer (located at 1123 Richland Circle, Columbus, GA 31907-5381) with Columbus Marshal's DARE program (Marshal Greg Countryman) about the title of the vehicle, which neither of them was able to produce for my viewing. Mr. Leslie Dinkins never repaired the vehicle.

After some time in 2011, I went to the Columbus Consolidated government center (located 100 10th Street, Columbus, GA-East Wing Phone: 706-653-4208) to have the title transferred back into my name from Eddie Florence, Jr., and that is when I discovered the title was still in my name. **EXHIBIT D, PAGE 22**

Upon realizing the title, and hence the vehicle, was still MINE, I decided to have the vehicle towed away from Mr. Leslie Dinkins and properly repaired. I spoke with my uncle and mother in regards to scheduling those arrangements. I arrived at Mr. Leslie Dinkins location to retrieve my vehicle, and explain the title confusion. When I arrived, the vehicle mysteriously disappeared, and when queried, Mr. Leslie Dinkins (located at 1537 Celia Drive, Columbus, GA 31906, Phone: 706-325-1999) did not know where the vehicle was located. I never gave Mr. Leslie Dinkins or my brother permission to move the vehicle from the original location 2525 Skylake Drive Columbus, Georgia 31907.

I had no knowledge the Theft by Taking (Motor Vehicle) report #11021201 I filed was cancelled on 08/09/2011, and I do not understand why I was arrested and taken into custody on 09/28/2011 when the case had been civilly adjudicated on 08/04/2011 With The Court.

On 09/28/2011, I went to the Columbus police department (Public Safety Building located at 510 10th Street Columbus, GA 31901, Phone: 706-225-4176) to file another separate complaint against the Department of Family and Children Services (located at 2100 Comer Avenue, Columbus, GA 31902- THE SAME BUILDING AS NEW HORIZON MENTAL HEALTH FACILITY; WELFARE; WIC; FOODSTAMPS).
