See OCGA §5-6-37.** Once the trial court clerk has received and filed the Notice of Appeal, the trial court clerk will prepare a copy of the record and transcripts as designated by the Notice of Appeal and transmit them to this Court. Once the Notice of Appeal is docketed in the Court of Appeals of Georgia, a Docketing Notice with the Briefing Schedule and other important information is mailed to counsel for the parties or directly to the parties, if the parties are representing themselves. You do not need to provide this Court with a copy of the Notice of Appeal you filed with the superior court.

**The Notice of Appeal must include a proper Certificate of Service.** A Certificate of Service must show service to the opposing counsel and contain the counsel's full name and complete mailing address. The opposing counsel must actually be served with a copy of your filing.

**An Application for Writ of Habeas Corpus should be filed in the superior court of the county in which you claim you are illegally detained.** An appeal from a denial of an Application for Writ of Habeas Corpus is to the Supreme Court and not the Court of Appeals.

**An Application for Writ of Mandamus should be filed in the superior court of the county official whose conduct you intend to mandate.** An appeal from a denial of an Application for Writ of Mandamus is to the Supreme Court and not the Court of Appeals.

slowly growing back. Currently I am  
alerting prison wardens that Betty Blass,  
her sister Marilyn Anderton and their niece  
Jennifer Lawson will have me further  
falsely imprisoned in their prison system.  
I am sure your thought I'd be  
medicated by now and driven to insanity  
as what happens to poor minority and  
poor single parents in Cobb when Betty  
Blass (DFAES) wants our children. Lampham  
fund has been being committed against  
me in the Cobb state, superior and  
juvenile court. On Feb 2, 2015 Betty  
Blass will rush me to a motion hearing  
where as inmates have already informed  
me all motions will be denied. I currently  
have sat in Cobb County jail for 5 months  
now. All the people I spoke of in my  
journals on facebook and my emails have  
run off with my children. I haven't  
seen them in 5 months. The people  
who stole them told my children they  
would never see me again and that

I need a "STAY" to save my life  
I need your help as well

And her wealthy community of white friends that frame blacks in Cobb Courts, ~~and~~ have created phony docs saying its my voice threatening. My emails and facebook page attest differently. You are aware they commit fraud all the time, their type, against minorities. I have written just judge Martin as an appeal for help requesting a "Stay" I dont seem to have ethical representation. She is helping to steal my children and putting me to death. A slew of government officials ~~have~~ have been written on an indictment paper all teaming up against me. They all have more money than me, a poor single, man stalked and terrorized so they could get and steal my children, and legal license that they are using to abuse and terrorize me; my children, my dog, all my property I am looking for. I am in chains go figure and have never committed a crime in my life. Betty keeps on sending people to the jail to ask me to be driven to insanity or medicated I refuse I was jumped, beat on in August 19, 2014 by one of her young deputy friends and brought here while they ran off with my kids, ~~and~~ my kids screaming

in terror. God knows! What country do I live in again? They then took me in chains to a probable cause hearing, I own no gun, I own no permit and <sup>they</sup> terrorized me, Committee found lied on me, and said I would gun down Jennifer Lawson. They mocked, jeered, lied on me, terrorized me and had me spit on in the jail and called a cunt.

There is a claim filed back from 2005/2006/2007 in the federal court with judge ~~at~~ Martin about Betty Bless Sanders Deen, and the terrorism I and other, moms suffer from these individuals who are at it again attempting to abuse their legal license to frame me for murder. Vic Reynolds didn't participate. Betty got a new P.A. which she gave the phony evidence to to frame me <sup>her name</sup> as Sherman Figueroa.
