Application For Discretionary Appeal

Jurisdiction

Jurisdiction of this criminal case on discretionary appeal is vested in the Court of Appeals of Georgia pursuant to O.C.G.A. § 42-12-8, and 5-6-35.

In The Court Below

On October 30, 2013 Wayne Kitchens filed a Motion To Vacate A Void Judgement in the Superior Court of Houston County pursuant to O.C.G.A. § 17-9-4, 17-10-1 (f). Crumbly v. State, 261 Ga. 610 (1991), after he discovered errors in his case that he was not made aware of prior to entering a plea of guilty.

These errors consist of the accusations failure to charge the essential elements of the offenses charged. O.C.G.A. § 17-7-54, 17-2-2 (a) (e). Smith v. Hardrick, 266 Ga. 54, 464 S.E.2d. 198 (1995).

ON October 15, 2014 the motion to vacate a void judgement was denied by ORDER of Judge George Nunn and a timely Notice of Appeal was filed with an attached forma pauperis.

In August of 2014 attempts to have a hearing were denied and on October 20, 2014 an out of time appeal was filed with the Superior Court of Houston County to perfect service on his appeal.

ON February 4, 2015, Wayne Kitchens Out of Time Appeal was denied by ORDER of Judge George Nunn.

This Application For Discretionary Appeal is filed on February 17, 2015 seeking review of the following:

Argument And Citation of Law

The basis of MR. KITCHENS motion to vacate a void judgement was to vacate the convictions and sentence imposed by the Houston County Superior Court for the offense of VGCSA- Poss. with Intent to Distribute and Poss. of Marijuana and consequently receiving a sentence of 15 years to serve.

KITCHENS discovered ERRORS in the charging document that was presented as an Accusation that failed to lay venue in Houston County as no specific address was charged, O.C.G.A. § 17-2-2 (a), Jones v. State, 272 Ga. 900 S.E.2d. 80 (2000), this being an essential element when the arresting officer's testimony stated the crime began in Bibb County and MR. KITCHENS was driving when the arrest

was made. O.C.G.A. § 17-2-2 (E). Stockard v. State, 327 Ga. App. 184 (2014).

At no time in this criminal case was venue set forth in a manner that established subject matter jurisdiction to accept a guilty plea by the trial court. U.S. v. Gayle, 967 F.2d. 483 (11th Cir. 1992).

This fact is further proven when the State provided no proof of a commitment hearing under Article 2 of O.C.G.A. § 17-7-20. Brackins v. State, 249 Ga. App. 188, 189 (2), 549 S.E.2d. 775 (2001).

The essential elements simply were not charged in this crime to constitute a guilty verdict, even if entered in the form of a guilty plea when the true nature of the offenses were not explained to Mr. Kitchens before entering his plea. Taylor v. State, 304 Ga. App. 878 (2012); Hill v. Lockhart, 474 U.S. 52, 56 (88 L.Ed. 2d. 203).

Relief Requested

Wayne Kitchens respectfully requests the Court to remand this criminal case back to the trial court with directions to vacate all convictions and sentence due to lack of jurisdiction of person and subject matter.
