

On 06/23/2014 I accessed the Georgia Bureau of Investigation (GBI) Division of Forensic Science (DOFS) website and received the DNA profile results from the sample collected from the sexual assault submitted in reference to the above case number. The resulting DNA profile developed was for Mattalynn Ward, the victim. I spoke with Jessica A. Romanoski, the Forensic Biologist at the GBI DOFS Crime Laboratory in Savannah, Georgia by phone. Ms. Romanoski explained to me in laymen terms that the DNA profile developed was the victims due to the victims DNA being present in the sample in such abundance compared to the offenders that it overwhelmed the offender's profile when developed. Ms. Romanoski told me that this sometimes occurs. Ms. Romanoski advised me there is another DNA test that can be performed to identify the male donor of the sample which was present in the sexual assault kit. I asked Ms. Romanoski to perform that test. Nothing further.
