On 03/25/15, the defendant refused to provide a urine sample for testing at the EMIT lab at the Dougherty County Jail. Special Other Condition: Probationer shall pay fine, fees and restitution at a rate of \$100 per month beginning 09/01/05. Probationer has failed to pay as directed. He is \$ 1,475.00 in arrears. Probationer was served with a waiver on 11/25/14 for 10 days jail and to complete Matrix Early Recovery Skills and Matrix Relapse Prevention. On 01292015 I was contacted at home by dispatch in reference to a burglary that occurred at 1309 W Society Ave Apt B. I responded to the LEC and made contact with Cpl Gulley. Cpl Gulley advised that they had a subject named Antonio Weston in custody in reference to this incident. Cpl Gulley advised that he was dispatched to 1309 W Society Ave to handle this burglary. Cpl Gulley advised that once he arrived on the scene he observed the back door of Lorenza Walker s apartment kicked in and footprints in the door entrance. Cpl Gulley advised that the foot prints appeared to be similar to the bottom of a converse shoe with the emblem. Cpl Gulley advised that Lorenza told him that a black female named Tammy Vicks told Lorenza that the suspects went into her house and were probably still there.
