551 F.3d 875, Conzalez v. Duncan, April 9, 2008, illegal recivist sentence violates 8th Amendment (551 F.3d 890) entitled to relief under 28 USC 2254(d)(1), In Fwing, the triggering offense of felony (551 F.3d 891) grand-theft past conduct and does not demonstrate any recivist tendency toward violent crime or 42-1-2 see Cluff, 105 Cr. Op. 2d at 87. see Reyes v. Brown 399 F.3d 964, 969 n. 9 (9th Cir. 2005) (holding that plea offers are relevant to determine whether a 3 strikes sentence is grossly disproportionate to triggering offense).
