

**APPLICATION FOR APPEAL OF ORDER
REVOKING PROBATION**

WAYMAN PRICE, Applicant, applies to the Court of Appeals of Georgia requesting leave to Appeal an Order of Honorable Joe C. Bishop, Judge of Randolph County Superior Court, revoking Applicant's probation, and in support thereof shows as follows:

1. JURISDICTIONAL STATEMENT:

This Application for Appeal from an Order Revoking Probation is brought pursuant to the provisions of O.C.G.A. Section 5-6-35(a)(5). The Court of Appeals shall be a court of review and shall exercise appellate and certiorari jurisdiction in all cases not reserved to the Supreme Court or conferred on other courts by law. Georgia Constitution, Article VI, Section V, Paragraph III. The Court of Appeals and not the Supreme Court of Georgia has jurisdiction of this Appeal since it is not a case in which the Supreme Court of Georgia has exclusive or general appellate jurisdiction pursuant to Article VI, Section VI, Paragraphs II and III of the Constitution of Georgia.

Therefore jurisdiction of this Appeal from an Order revoking probation is proper in this Court.

2. NATURE OF ORDER BEING APPEALED:

This is an Appeal from an Order revoking Applicant's Probation. Applicant was on probation from a sentence imposed in Randolph County Superior Court on August 10, 2004, in Case Number 2004-CR-140, pursuant to the entry of a negotiated plea of guilty to the offense of Sale of Cocaine, and Case Number 2004-CR-139, pursuant to the entry of a negotiated plea of guilty to the offense of Burglary. The State of Georgia filed a Petition for Modification/Revocation of Probation to revoke Applicant's probation and a hearing was had on said petition on March 26, 2015. The Court, after hearing testimony and evidence, entered a Probation Revocation Order revoking the entire balance of Applicant's probation on March 26, 2015. The Probation Revocation Order entered by the Court is not interlocutory but is a final Order.

3. ENUMERATION OF ERRORS TO BE URGED ON APPEAL:

The evidence adduced at the hearing on the Petition for Modification/Revocation of Probation was insufficient to justify the Court's finding from a preponderance of the evidence that the Applicant had violated the terms and conditions of his probation.

4. TIMELINESS OF APPLICATION:

The Probation Revocation Order of the Superior Court revoking Applicant's Probation was entered on March 26, 2015. This Application for Appeal from that Order is being made within thirty days of the entry of the Order as required by O.C.G.A. Section 5-6-35(d).

b. Copy of Request for Transcript of proceedings (Exhibit "B")

WHEREFORE, Applicant respectfully requests that this Court allow the Applicant the opportunity to appeal and be heard on the issue of whether or not the Applicant violated the terms and conditions of his probation as well as other issues addressed by the Probation Revocation Order of the Superior Court entered on the Petition for Modification/Revocation of Probation.






