I. Jurisdiction

This honorable court retains jurisdiction to adjudicate this case pursuant to the Georgia constitution as well as Georgia statutes.

II. Complaint

1. The plaintiff-petitioner, Xavier Sims, is currently incarcerated at the Federal Correctional Complex located in Coleman, Florida.

2. He is incarcerated there pursuant to the Judgment of a Federal Court for the violation of Federal supervised release.
3. While serving said violation of supervised release, the defendant-respondent, the Colquitt County Prosecuting Attorney, filed a criminal charge against Sims related to the theft and/or use of a credit card.
4. The Colquitt County Prosecuting Attorney knows exactly where Sims is incarcerated.
5. However, the Colquitt County Prosecuting Attorney refuses to lodge a detainer against Sims so that Sims can demand a speedy trial on the case.
6. The Colquitt County Prosecuting Attorney refuses to lodge the detainer because Sims would then be able to demand a speedy trial under the Interstate Agreement on Detainers which would require the Colquitt County Prosecuting Attorney to have Sims transported from Florida to Georgia and have the case disposed of within 180 days.
7. However, the Colquitt County Prosecuting Attorney does not want to have Sims extradited. Rather, the Colquitt County Prosecuting Attorney wants to wait until Sims is released and voluntarily returns to Georgia to do anything with the case.

8. Yet, the Colquitt County Prosecuting Attorney has brought a new criminal charge. Sims has a constitutional right to demand a speedy trial.
9. The Colquitt County Prosecuting Attorney is under a clear legal duty to lodge the detainer.
10. Sims has a clear legal right to have the detainer lodged.
11. Sims has no adequate remedy in the ordinary course of law to require the Colquitt County Prosecuting Attorney to lodge the detainer.

### III. RELIEF

WHEREUPON, Sims respectfully requests this honorable court order the Colquitt County Prosecuting Attorney to immediately lodge the detainer.
