### APPLICATION FOR PERMISSION TO APPEAL A PROBATION REVOCATION

- To appeal a probation revocation, you will need to file a Discretionary Application with this Court. Rule 31 of the Rules of the Court of Appeals of Georgia describes a Discretionary Application and the items you would need to include with your application.

A Discretionary Application must be filed within 30 days of the stamped filed date on the order that you are appealing and the application must be accompanied by a proper Certificate of Service and a pauper's affidavit or the \$80.00 filing fee. You must also comply with all the other applicable rules of Court regarding filing with the Court of Appeals of Georgia.

Dear Clerk of Court,

I need some information for my sister and myself. My sister thinks you have been suborned by Daniel King of the Attorney General's office and possibly by Richard Mallard, the district attorney of Statesboro into not sending my ANSWER to the court. I told my sister that you had been doing what's right by law. So far. And. There is no proof that you have been suborned by Daniel King, or anyone. He has twice suborned Gene Johnson of Mc Rae, clerk of court. Richard Mallard has suborned the clerk of court of Statesboro five times. They suborned the clerks into not sending any of my filings to the judge, causing dismissals against me. Jack Williamson, my ex-attorney was paid five thousand dollars to help convict me. He conspired with the D. A. Mallard to stand mute at trial and let me be convicted. Williamson became "a friend of the state". He did not tell Mallard or King that he was paid five thousand dollars. Maybe he didn't want to share the spoils. These three criminals conspired with others (clerks of courts) to help keep me in prison. My sister has a list of fourteen who will have civil rights charges brought against them, and state and federal criminal charges against them. They all will lose their jobs. They all will have state and federal lawsuits of ten million dollars filed against them. The main three will be the first. They conspired to convict an innocent person and then kept conspiring to keep me in prison. There was no crime committed by anyone against anyone. I will get justice. My sister has gotten Diane Dean of channel 10 news of Albany interested in my case. Along with others, she brought down criminal judges, lawyers, clerks of courts, and others, not long ago. She is getting fixated on Statesboro (Richard Mallard, et al) and the attorney general's office (Daniel King, et al). Because of my case. And. Diane Dean can not be suborned. So. You see now why my sister thinks that you have been suborned by King/Mallard into not sending my ANSWER package to the court. And. She thinks you should be number 15 on her list. I think you know that King/Mallard can do nothing to you for following the law and doing what is right. They can not hurt you but being on my sister's list can and will.

So. The information we need is to know for sure that my ANSWER package has been sent to the court judges. I sent my ANSWER to you on December 31, 2014. You would have received it in January. My case number is A14A2121. Could you please show that the court received my package?

Everyone wants justice. You do. I do.
