writing you in 2014 about my 2 charges and false imprisonment. I didn't go back to review what I wrote you but finally on 7/2/2015 Judge Louisa Abbot tricked me and had a bench trial. So I filed the Notice of Appeal 5-6-37 to the Superior Court Clerk this coming Tuesday but she had me committed saying I was not competent. Enclosed are the details of the trial and I wanted to get all the warrants that she didn't consider and send to you. I have sent you what I have copies of and Superior court clerk are not going to include the warrants or police reports.

First let me start with my testimony and I apologized to the court because they seem to be offended that I don't want to play the system and file mental health. But Judge Abbot would only take a guilty by insanity plea. Which I refused to give her. I asked for my first offenders plea first felony and she just refused, Now the felony was 16-10-20 False Statements. Which was an intruder call to the policeman that clearly by his statements was holding a grudge or vendetta because I reported him in 2010 and he reminded me in July 10, 2014 that he was the "street supervisor for the day" but he never secured the house.

He became obsessed with my gun and asked when I used it last and I told him I was returning from a work contract in Florida because I'm a traveling nurse so I may have used it in Dec 2013 or March 2014 when I realized my house was robbed.

Back to my testimony I told Judge Louisa Abbot that I was raped and after being threatened by the police that they were going to incarcerate me if I call them again I purchased a gun and

started shooting at my intruders ^{who} ~~whom~~ raped me. She was aware on 5/28/2015 that I fired my racist attorney back in March under the mandamus and she continued to allow him to come and cancel court appointments, court trials, and both Judge Louisa Abbot and Lloyd Murray Sr. and assistant district attorney all said there was a deal on the table. So they have been cancelling trial, court dates then refused to let me take my first offenders because I wrote Meg Heap informing her about situations around the jail. They have had 2 jumpers in here and 1 beaten to death.

So my angry attorney got his best friend who is a psychiatrist to overturn and stamp me crazy because I wrote Meg Heap's office about a number of things. Now here is just a few stars that announced to the city by the news that they were here in town making movies Robert Deniro (Dirty Old Grandpa) Gabriel Union (Do Over) Adam Sandler and David Spader are looking for extras.

So I asked the District Attorney's office to inquire were there any stars leasing some parts of the jail because of the ceramic toilets and sinks for 1. And I provided her with a list of witnesses that I needed her office to subpoena and officers that are no longer employed after holding me here a year. Well the angry fired attorney got a copy of the letters and gave them to his friend the psychiatrist and they said I was delusional for that and simply crazy because who does that.

Well I did because I have been under duress because Judge Louisa Abbot refused to grant me a bond after the state hired psychiatrist said I was competent in 11/5/2014 but the fired attorney wanted me to plead insane.

Just a little about what happened on 7/2/2015 they just refused to call all the witnesses and give me a trial. The officer was obsessed with feces and I swear that conversation never took place but I sat here a year based on his lies and their united front to have me plead insane.

losers in society played the system with mental health plea and I

Hopefully you will better understand as you read the
evidence I submitted because Judge Louisa Abbot had allowed none in
court room on 7/2/2015 except my testimony and the angry racist
attorney's best friend whom was fired since ~~February~~ ^{March} 2015. And again
it is all factual and true the letters I ~~wrote~~ ^{wrote} to the Districts Attorney
Meg Heap. I am responsible for my own defense so I had 2 weeks
prior to trial which should have been May 18 or 19th set by Louisa Abbot
to provide them with my list of witnesses. And when I asked them
for their new charges they ignored and refused me. Now Phillip Barrin
State hired psychiatrist deemed me competent on 11/5/2014 but said
he thought I was delusional because I locked my gate. But he didn't
read the police reports until after he left the evaluation.

I eagerly await your decision after finally getting her
to set trial dates and cancelling but tricked me on what she said was
a bench trial. I am hoping you can still review all the evidence and
make a decision. Don't forget about the famous state access video of
preliminary hearing on 7/23/2014.
