

THE JUDGEMENT IS CONTRARY TO LAW AND THE PRINCIPLES OF JUSTICE AND EQUITY, WHERE UPON THE DEFENDANT DEMAND THESE GROUND FOR A NEW TRIAL BE INQUIRED OF BY THE COURT AND THAT A NEW TRIAL BE GRANTED.
