- An Application for Writ of Habeas Corpus should be filed in the superior court of the county in which you claim you are illegally detained.** An appeal from a denial of an Application for Writ of Habeas Corpus is to the Supreme Court and not the Court of Appeals.
- An Application for Writ of Mandamus should be filed in the superior court of the county official whose conduct you intend to mandate.** An appeal from a denial of an Application for Writ of Mandamus is to the Supreme Court and not the Court of Appeals.
- Your appeal was disposed by opinion (order) on _____.** The Court of Appeals _____
_____ The remittitur issued on _____
divesting this Court of jurisdiction. The case decision is therefore final.

- As long as you are represented by an attorney, you cannot file pleadings on your own behalf. Your attorney must file a Motion to Withdraw as Counsel and it must be granted, before you can file your own pleadings in this Court. - A request for an out-of-time appeal should be made to the trial court from which you are appealing.** If your motion is denied by the trial court, you can file an appeal of that decision by filing a Notice of Appeal with the clerk of the superior court.

Anyway, in closing I would like to add that my nephew Marcus Ware who is a associate professor at Howard University got his law degree and passed the bar in D.C., - I believe, we are estranged because he feels the family can't accept that he is gay. Hey, I grew up in Alabama the Bible belt, the home of Chief Justice Roy Moore, but being a straight black male, and being incarcerated for 12 years, I know now probably what I didn't know before, whatever he does, is his business, you feel me. I still love him, and respect his intelligence more than ever, anyway once again, - I'm pleased with the job that you did, and I expect to hear some great news in the next couple of months from the Court of Appeals.
