
The clerk's office of the Court of Appeals of Georgia is located at Suite 501, 47 Trinity Avenue, S.W., Atlanta, Georgia 30334. Our office hours are from 8:30 a.m. until 4:30 p.m., Monday through Friday, excluding legal holidays. We have a drop box located at the street level entrance for after hours filings which cannot be e-filed. While we close at 4:30 p.m., the Georgia Building Authority generally does not lock the building until 5:00 p.m. Any documents placed in the drop box between 4:30 and 5:00 p.m. will be retrieved the following business day and docketed to the previous business day. Any filings which require a filing fee must be accompanied by the filing fee. We suggest you use a check rather than cash when filing in the drop box.

Electronic filing of documents is available at the Court of Appeals. The Court has implemented a new case management system which permits most filings to be e-filed and permits the Court to distribute its opinions, as well as orders, electronically to you.

The Court web site also has additional information about the judges, directions to the Court, e-filing, suggested Standards of Review, caseload statistics, and other hyper links you may find useful. The Court's website also has a link entitled "Ask the Clerk". You are free to e-mail me any questions or suggestions you may have, and of course, you may call me if you like.
