For the Supreme Court, you will line up to sign roll books by last name A-L and M-Z. You will need to know the date you were admitted to the Bar (Superior Court's Oath). You will be asked for the city and state of your home or work address.

For the Court of Appeals, you will line up by last name A-L and M-Z. You will need to know the date you were admitted to the Bar (Superior Court's Oath).
