As of August 14, 2008 there were 335 Interlocutory applications docketed and 495 Discretionary applications docketed for the year 2008.

As of the closing docket for 2007 we had 365 Interlocutory applications and 406 Discretionary applications docketed.

That is 30 less Interlocutory applications this year from last year and 89 more Discretionary applications docketed this year from last year.

The total number of applications docketed for 2008 is 830 .The total number of applications docketed for 2007 were 771. We have an increase in applications this year by 59 applications. If you have any questions on this matter, please let me know.

The following is a percentage report showing the difference in how many discretionary and interlocutory applications were filed in a six month period from January - June of 2007 and January - June of 2008.

There were **211** discretionary applications filed from January - June of 2007.

There were **253** discretionary applications filed from January - June of 2008.

That is a 7% increase for discretionary applications.

There were **186** interlocutory applications filed from January - June of 2007.

There were **163** interlocutory applications filed from January - June of 2008.

That is a 3.84 % decrease in filings for the interlocutory applications.

All in all we have had a 3.16 % increase for the applications all together for the months of January - June of 2007 to 2008. If you have any questions please do not hesitate to let me
