Mr. Martin has asked me to provide you the two attached reports of judge transfers. One is for calendar year 2005 and the second for 2006 to date. The following notes should help you read the report.

1. The initial column of the report shows the transfer case numbers. Next, you will see the reason for the transfer and from which judge to which judge the transfer was made. For example, Case Number A06A0103 was transferred to Judge Mikell to author with Judge Smith added to the panel to vote since Judge Blackburn recused. In this column, the R stands for recused and D for disqualification. The designation of R or D is based on the judge's memorandum to me. This column also shows if the transfer was made to assign a companion case to the same judge as the main case. The number of the companion case is listed in the next column.

2. If a yes appears in the DKT SUB YEAR column, then, at the time of the transfer, the docket for the year was closed. Therefore, we were unable to equalize the number of cases assigned for the year to the judges involved in the transfer.

3. The date column is the date that the transfer occurred.

4. The column headed OA shows whether the case was scheduled for oral argument. The oral argument date follows in the last column. A note at the bottom of the chart, displays the number of transfers that occurred before oral argument.

5. At the bottom of the appropriate columns of the report there are totals.
