ATTACHED IS A TEN YEAR SUMMARY OF THIS COURT'S CASE LOAD WHICH INCLUDES THE FIGURES FOR 1992.

PLEASE NOTE THE 7.7% INCREASE OVER THE NUMBER OF DIRECT APPEALS DOCKETED IN 1991, 8.7% INCREASE IN THE NUMBER OF DISCRETIONARY APPLICATIONS FILED IN 1991 AND 7.4% INCREASE IN INTERLOCUTORY APPLICATIONS FILED IN 1991. THIS MEANS A TOTAL OF 379 CASES PER JUDGE IN 1992, 30 MORE CASES THAN IN 1991.

IN 1986 WE FILED MORE DIRECT APPEALS, BUT FEWER APPLICATIONS WERE FILED FOR A SMALLER TOTAL NUMBER OF CASES PER JUDGE FOR THAT YEAR.
