## SUPERIOR COURT APPELLATE JURISDICTION

In an effort to divert some of the ever increasing case load of the Court of Appeals, it has been suggested that the Court take a serious look at Article VI, Section 4, Paragraph 1 of the Constitution of the State of Georgia. This constitutional provision provides that "the Superior Court shall have such appellate jurisdiction, either alone or by circuit or district, as may be provided by law". It would seem that this constitutional provision would require only enabling legislation to carve out such appellate jurisdiction for the Superior Courts as may be deemed necessary and advisable.

In that regard in looking at the case type filings for the Court of Appeals of Georgia, one can glean from the filings report those areas where cases are filed most in the Court and those areas in the Court in which cases can be diverted to an appellate panel of Superior Court Judges.

The Case Type Filing Report for calendar year 1992 - 1993 for the Court of Appeals of Georgia is as follows:

In an effort to locate cases that can be diverted from the Court of Appeals to an appellate division of the Superior Courts, the emphasis should be toward removing from the Court of Appeals those cases on the lower end of the spectrum in terms of importance on appeals. In that regard, it is suggested that the following types of cases be diverted to the Superior Court Appellate Division:

1. Interlocutory Applications
2. Discretionary Applications
3. Misdemeanor Cases for Dispossessories

#### INTERLOCUTORY APPLICATIONS

It is recommended that an appellate tribunal of Superior Court Judges hear all interlocutory applications. If the Superior Court Appellate Division granted an interlocutory application, then that superior court appellate division would hear the appeal that emanated from the grant. An appeal from the decision from the Superior Court Appellate Division to grant or deny the application would be by certiorari to the Supreme Court of Georgia. An appeal from the ruling on the direct appeal emanating from the grant of the interlocutory application, either affirming or reversing the trial court, would be by certiorari to the Supreme Court.

The parties in an interlocutory appeal always have the right to preserve by proper objection at the trial of the case the action they claim to be error and have it brought before the Court of Appeals by direct appeal at the end of the case.

#### DISCRETIONARY APPLICATIONS

It is anticipated that the Superior Court Appellate Division will consider discretionary applications. In workers compensation cases, the decision of the Superior Court Appellate Division would be appealable to the Supreme Court of Georgia by certiorari. These cases do not need to come to the Court of Appeals since they have already been passed upon by an administrative law judge, a board of three workers compensation administrative law judges, and a superior court appellate division of three superior court judges sitting as a panel.

In the other types of cases coming before the Superior Court Appellate Division on application, a grant or a denial of the application would be appealable to the Supreme Court by a writ of certiorari. A grant of the application would have the case decided by the Superior Court Appellate Division with right of certiorari to the Supreme Court by either party dissatisfied with the Superior Court Appellate Division's ruling.

### MISDEMEANOR CASES

Misdemeanor cases, over 50% of which are made up of DUI and other traffic related cases, would be heard by the Superior Court Appellate Division with right of certiorari to the Supreme Court.

### DISPOSSESSORY CASES

Dispossessionary case, those not heard by discretionary application, would be heard by the Superior Court Appellate Division with right of certiorari to the Supreme Court.

The elimination of interlocutory applications, discretionary applications, misdemeanors and dispossessionary cases from the Court of Appeals would have removed 1111 cases from the Court in calendar year 1993. The bulk of these cases, 482 & 438 are discretionary and interlocutory applications respectively. 141 misdemeanor cases and 50 dispossessionaries round out the 1111 cases. Of the 141 misdemeanor case, 76 were appeals from DUI convictions.

### Structure of the Superior Court Appellate Division

It is anticipated that the Superior Court Appellate Division will be divided into five appellate division made up of panels of superior court judges, consisting of ten panels of three, the panels sitting as combinations of two judicial administrative districts. For example, the first and second judicial administrative districts would have a panel of three judges each, which panels would serve for a period of one year. The panels for the first and second districts would hear cases assigned to it from districts other than the first and second districts.

The Council of Superior Court Judges would staff an appellate division for administrative purposes, hopefully, Pam Allen, who would assign the cases to the panels on an equal, random and rotating basis. The applications or notices of appeal would be filed with the trial court as an original and three copies. The three copies would then be sent to Pam Allen who would assign the cases to the various panels throughout the State.

The panels would review the cases and render a decision on applications and opinion on direct appeals.

If an appeal were not unanimous, it would be circulated to two other panels so that a total of nine superior court judges would pass upon cases in which the panel was not unanimous, very much like whole court cases in the Court of Appeals.

In the grant or denial of applications, the vote of one, two or three judges would be necessary to grant an application, dependent upon rules and procedures as devised by the Superior Court Appellate Division.

It is anticipated that each of the ten panels would here approximate 111 cases per year, of that number approximately 900 would be applications.


