

As per your request, I have attached several reports detailing the case filings and dispositions of the Court of Appeals of Georgia. Of particular note is the number of written opinions issued by the Court of Appeals of Georgia. The Court of Appeals of Georgia is far and above the busiest appellate court in the country in terms of the number of written opinions per judge.

The comparative figures for Georgia and the rest of the nation are for 1992. At that time, the Court of Appeals of Georgia was issuing 229 written opinions per judge per year. The closest state to Georgia is Pennsylvania at 185 opinions per year, with Alabama coming in third at 152 opinions per year. However, Alabama is adding two judges to its civil court of appeals, to bring that total to five, added to the five judges on the criminal court of appeals, for an overall total of 10. The ranking of the opinions for 1992 can be found in Exhibit A, attached hereto.

In addition to writing 229 opinions in 1992, the Georgia Court of Appeals also had to deal with 957 applications, which, while not

technically having an opinion written, take considerable time and effort by the Court. This would be like adding an additional 97 opinions per judge to the already nation-leading total.

In 1993, the number of opinions per judge written by the judges on the Georgia Court of Appeals was 250. Again, the Court dealt with 925 discretionary and interlocutory applications as well. While we cannot give a final figure as to written opinions in 1994, there have been 2,842 direct appeals filed in 1994, an increase of over 10.2 percent from the previous year. The applications will not close out until December 31, but already the number of discretionary applications has far exceeded the number filed in 1993, and the number of interlocutory appeals for 1994 will top 1993 totals as well. A ten-year comparison of the case filings with percent increase for direct, discretionary and interlocutory appeals can be seen as Exhibit B attached hereto.

Exhibit C, attached hereto, is an alphabetical listing of the state courts of appeal, giving the number of opinions written for each state, the number of judges on each state's court of appeals and the number of written opinions per judge for 1992. Finally, Exhibit D lists the states in the southern region in descending order of the number of opinions per judge. Again, Georgia far exceeds the written opinions of the other states in the region.
